Motion made by Mr. Knittel to perform a camera inspection of the unmapped sewer lines discovered by Senate Engineering Company during the I/I study. Second by Mr. Blair. Motion carried.

Motion made by Mr. Blair to purchase a laptop for the borough not to exceed the amount of \$6,000.00. Second by Mr. Knittel. Motion carried.
